

# **Data Protection Regulation**

CAMPING VILLAGE ISOLINO SRL, as data controller, according to art. 13 and 14 of the **European Regulation UE 679/2016** – **General Data Protection Regulation (GDPR)**, in compliance with the obligations prescribed by the legislator in order to protect privacy, hereby wishes to inform you about both the use of your personal data and your rights, conveying what follows:

### a) DATA CONTROLLER AND OTHER RESPONSIBLE SUBJECTS

The data controller is CAMPING VILLAGE ISOLINO SRL, tax code 00624990032, Headquarters in via per Feriolo 25, 28924 Verbania Fondotoce (VB) – VERBANIA – Italy Email: campingvillageisolinosrl@pec.it. ## b) PERSONAL DATA PROCESSED

Non sensitive personal data (identification, accounting, financial data etc.) – Processing time: 10 years

# c) PURPOSE, JURIDICAL FOUNDATIONS AND COMPULSORY OR DISCRETIONARY DISPOSITION OF THE PROCESSING

The source of the data mentioned in point b is: phone/website/email/fax/post/exhibitions
Main purposes: fulfillment of commercial offers, check-in/check-out, on the spot assistance and more
Juridical foundation: the processing is necessary for the implementation of a contract in which the person
concerned is part of or pre-contractual measures adopted on request of the concerned person.

## d) ADDRESSES

Only for the purposes aforementioned, the personal data will be made known both to the appointed employees and to external cooperators selected for their processing (data controllers), list of which is available at the data controller's headquarter.

## e) TRANSFERS

No personal data transfer is possible to addressees outside the European Union.

Personal data will not be transferred to others. In exceptional cases, data will be shared with Malù srl (Camping Village Continental at Lake Mergozzo in Verbania and Hotel Residence Zust in Verbania), in order to process booking requests.

## f) DATA CONSERVATION

All bestowed personal data will be processed respecting the principles of lawfulness, fairness, pertinence and proportionality and only by means of IT or telematic methods which are strictly necessary to pursue the aforementioned purposes. In any case personal data will be kept for no longer than strictly required for the pursuing of the aforementioned purposes. Personal data for which conservation is not necessary, not dictated by the current legislation nor related to the aforementioned purposes will be cancelled or made anonymous. Duly note that the informatic systems used to manage the collected information are configured from the start to minimize the use of data.

#### g) YOUR RIGHTS

We remind you that the addresses have the right to access any time their own personal data by making a formal request directly to the appointed Data Processor in charge of Personal Data handling, at the Data Controller's address:
